**Waiver and Assumption of Risk**  
**Dog Days at the CAC**

I acknowledge that I voluntarily have applied to participate in and use, with my dog(s), the Cumming Aquatic Center aquatic facilities (“Aquatic Facilities”) for the Dog Days at the CAC event on Saturday, September 7<sup>th</sup>, 2024, and/or Sunday, September 8<sup>th</sup>, 2024, and/or Saturday, September 14<sup>th</sup>, 2024 (“Dog Days Event”).

I understand that the act of unleashing my dog(s) and being physically present inside the Aquatic Facilities area necessarily involves risks of injury to me, to other people, to my dog(s), and to other dogs. I understand these risks are entirely my responsibility. I expressly assume these risks. I am aware of the risks and hazards inherent upon entering the Aquatic Facilities area and I choose to voluntarily enter the premises, knowing the conditions might become more hazardous and/or dangerous for myself and/or my dog(s), and I voluntarily assume all such risks, loss, damages, or injury that may be sustained by entering the Aquatic Facilities.

By signing this Waiver and Assumption of Risk and using the Aquatic Facilities, I hereby fully and forever release and discharge the City of Cumming, Georgia, the Cumming Aquatic Center, and their respective volunteers, employees, officers, officials, and agents from any claims, demands, injuries, damages, rights of action, or causes of action, past, present, or future, whether the same be known or unknown, anticipated or unanticipated, resulting from, arising out of, or in any way related to my use or that of my dog of the Aquatic Facilities.

I fully and forever release and discharge the City of Cumming, Georgia, the Cumming Aquatic Center, and their respective volunteers, employees, officers, officials, and agents from any and all negligent acts and omissions resulting from, arising out of, or in any way related to the Dog Days Event. By signing this agreement I agree to indemnify the City of Cumming, Georgia, the Cumming Aquatic Center, and their respective volunteers, employees, officers, officials, and agents from any claims, demands, injuries, damages, rights of action, or causes of action, past, present, or future, whether the same be known or unknown, anticipated or unanticipated, resulting from, arising out of, or in any way related to my use or that of my dog of the Aquatic Facilities.

## **Rules of Participation**

1. Absolutely no humans allowed in the water, except to introduce the dog to the zero-entry area.
2. Each person must sign the Waiver and Assumption of Risk and acknowledge the event Rules, before entering.
3. All dogs must have current proof of all vaccinations: (parvo-distemper, rabies, bordetella (kennel cough)).
4. Be courteous to other guests and clean up your dog's "accidents."
5. Your dog may be released from their leash only upon entering the designated Aquatic Facilities area.
6. Please do not trim your dog's nails prior to attending the Dog Day at the Outdoor Leisure Pool.
7. No minors (persons under the age of 18 years) allowed without adult supervision.
8. Your dog must remain under your control at all times. If your dog is acting aggressively, you and your dog may be escorted from the event.
9. Please be sure your dog has been exposed to swimming. Some dogs swim well, some don't. If not, he/she may become afraid or aggressive.
10. Please help your dog into and out of the pool.
11. All dogs participating must be spayed or neutered.
12. No dogs with health conditions that may endanger themselves or others are allowed.
13. Outside food or drinks (pet or human) are not allowed in the Aquatic Facilities area.
